As per University Rules and Regulations, the College will have to follow the following terms & conditions.

- 1- These colleges will have to complete all the requirement/ formalities for running B.Ed./ B.A.- B.Ed./B.Sc.- B.Ed. colleges as per the norms laid down by the NCTE, UGC, State Government and University Affiliation rules.
- 2- Qualified Principal and faculty is to be appointed as per the NCTE norms and University rules.
- 3- These Colleges should have Library , Laboratories, Computer lab and other infrastructure requirement as per the NCTE and University norms.
- 4- The University inspection Committee will inspect/reinsert the college and if the proper requirement are not found, the above permission shall be treated as withdrawn.
- 5- This NOC is Purely provisional and subject to the fulfillment of all the conditions laid down by the NCTE, State Government and University Affiliation rules.
- 6- The Univeristy has legal rights to withdraw affiliation of the college any time, if the conditions are not found satisfactory.
- 7- These colleges if not found proper will have to go through re-inspection and the reinspection fee will to be deposited by the concerned colleges within a month to complete the deficiencies pointed out to them .
- 8- All the requirements will have to be completed within one months's time.

If the infrastructure and Faculty in the College is not found proper in accordance with the affiliation rules/NCTE norms/State Govt. norms., during the course of inspection , the College shall

be subject to dis-affiliation and the students of such College shall be transferred to some other Colleges.

It is requested to the Coordinator, PTET M.D.S. University, Ajmer to kindly take decision for allotment of the candidates at your level as per the direction of the Govt. The above college will have to strictly follow the rules and regulations of NCTE, State Govt. and the affiliation rules of this University. The colleges will be subject to provisional affiliation only on fulfillment of all the terms and conditions as mentioned above.

WHEREAS in terms of section 14(1)/15(1) of the NCTE Act, 1993, the institutions had submitted applications to the Northern Regional Committee of NCTE for grant of recognition/permission for Teacher Education Courses.

2. AND WHEREAS on scrutiny/perusal, veracity of the facts & figures as per the application submitted by the institutions mentioned in table below, the documents attached therewith, the affidavit and the input received from the visiting team in the form of visiting team report including videography and also the reply submitted by the institution against decision of clause 7(13) of the NCTE Regulations, 2014, the Northern Regional Committee in its meeting held from time to time (mentioned against each of the institution) is satisfied that the institution/society fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the concerned Teacher Education Programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory, etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms and as per the approval of faculty given by the affiliating bodies.
